Enclosed is a copy of the Long Island Junior Soccer League "Membership Application Form and Questionnaire". Please provide all of the requested material and information and forward to: Chairman, Membership Committee, Long Island Junior Soccer League Inc., 701-9 Koehler Avenue, Ronkonkoma, New York 11779.

Membership in the League requires that a member club enter teams in League Competition during the Seasonal Year. (September 1 of the same calendar year through August 31 of the next calendar year, defined as a "Seasonal Year": - Fall and Spring Seasons).

Registration: All registration must be done online Got Sport (If another platform is going to be used then all information must be uploaded in the Got Sport platform). Fees currently include:

- 1) Club Annual Membership fee of \$100
- 2) Team registration fee of \$375 per team per season (Referee fees are paid by the team on the field)
- 3) Player registration fee of \$31 per travel player, \$8 per intramural player per seasonal year
- 4) Convention fee \$100 per year
- 5) Club Administrator Bond \$300 per year

League rules require that member clubs must be registered and known by the name of the town, community or school district on Long Island (or the appropriate geographical area of the petitioning club). League rules do not permit ethnic or religious designations.

Please return the attached forms as soon as possible so that we may resolve any open questions regarding your petition prior to the Board of Directors rendering a decision.

The request for membership **must be received on or before March 31, 2023**, as per the Long Island Junior Soccer League bylaws in order to be considered for membership in league competition for the forthcoming 2023-2024 Seasonal Year.

Membership Guidelines

1. Club functioning a minimum of 2 years.
2. A minimum of 150 children participating in a viable (*fall and spring season*) intramural program over the age of 7 years. Players must be registered with Eastern New York Youth Soccer Association through the Got Sport online registration system.
3. Competition provided in at least 2 age groups under 14 years.
4. Placement of travel teams does not jeopardize the intramural program.
5. Written comments by adjoining clubs to be requested.
 - A) For stability of existing club.
 - B) Avoidance of overabundance of clubs in area.
6. Permits in place for club's existing fields. Shared fields or temporary use permits are **not** acceptable.
7. On probation for 3 years in regard to sportsmanship and character, and the continuance of the intramural program.
8. Recommendations to Board of Directors for acceptance.

Membership Guidelines

1. An application form for membership in LIJSL will be updated each year with requirements needed to become a member of LIJSL.
2. All clubs with LIJSL travel teams have voting privileges and are required to pay a one-hundred-dollar membership fee each fall season.
3. All clubs with voting privileges are required to maintain an intramural program to retain their LIJSL membership.
4. All clubs with voting privileges are required to register all their intramural players with ENYYSA through the Long Island Junior Soccer League Got Sport online registration system in order to retain their LIJSL membership.
5. Clubs with voting privileges that are absent for a mandatory President's meeting will be fined one hundred dollars. If a second consecutive absenteeism occurs for a President's meeting the club will incur a \$100 fine. If a third consecutive absenteeism occurs for a President's meeting the club will be notified to attend a hearing to determine the status of its membership.
6. Clubs with voting privileges that are absent for a mandatory Registrar's meeting will be fined one hundred dollars. If a second consecutive absenteeism occurs for a Registrar's meeting the club will incur a \$100 fine. If a third consecutive absenteeism occurs for a Registrar's meeting the club will be notified to attend a hearing to determine the status of its membership.
7. All clubs must use the service of the LIJSL online registration provider to register all their players and teams.
